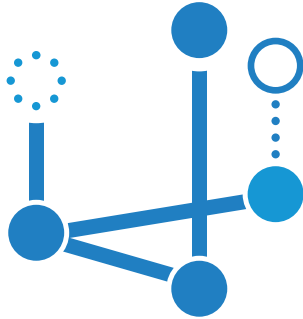
Hera Capital

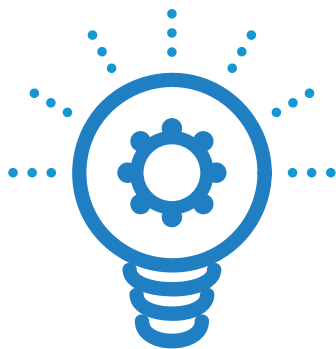
